1 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO: 2 SECTION 1. [NEW MATERIAL] SHORT TITLE.--This act may be cited as the "Safe Staffing Act". 3 SECTION 2. [NEW MATERIAL] DEFINITIONS.--As used in the 4 5 Safe Staffing Act: "ancillary staff" means a certified nurse 6 Α. 7 assistant, a medication aide, an obstetric technician, a gastroenterology technician, an emergency room technician, an 8 operating room technician, a behavioral health aide, a unit 9 secretary, a nursing aide, an orderly and any other personnel 10 who assist in the provision of nursing care; 11 12 Β. "committee" means a nursing staffing committee; C. "department" means the department of health; 13 "hospital" means any general or special hospital D. 14 licensed by the department, whether publicly or privately 15 owned; 16 "nurse" means a registered nurse and a licensed Ε. 17 practical nurse; and 18 "unit" means a hospital nursing unit. F. 19 [<u>NEW MATERIAL</u>] COMMITTEE REQUIRED.--A hospital SECTION 3. 20 shall have a nursing staffing committee composed of eleven 21 members as follows: 22 seven nurses who provide direct patient care but Α. 23 are not hospital nurse managers or hospital administrators, and 24 at least one of whom provides direct care in a nurse specialty 25 .195860.1

SECTION 4. [<u>NEW MATERIAL</u>] DUTIES OF COMMITTEE.--A committee shall:

A. develop a staffing plan for each of the hospital's units;

B. select outcome indicators for each unit from among the national database of nursing quality indicators, hospital compare, patient satisfaction surveys and such other appropriate standards as determined by the committee;

C. conduct an annual or more frequent review of the staffing plan for each unit to update or modify the staffing plan as determined by the committee; and

D. conduct an annual or more frequent review of outcome indicators for each unit to update or modify the outcome indicators as determined by the committee.

SECTION 5. [<u>NEW MATERIAL</u>] NURSING STAFFING PLAN REQUIREMENTS.--Each unit's staffing plan shall:

A. specify the minimum number of nurses and ancillary staff required for each shift on the unit based upon the level of intensity of care required by patients and the variability in the number of admissions, discharges and transfers under existing conditions;

B. take into account conditions or circumstances .195860.1

1 specific to a rural, general or acute care hospital; 2 C. ensure that a nurse shall receive adequate 3 orientation before being assigned to a unit; and specify circumstances, such as a declared state 4 D. of emergency, under which compliance with the staffing plan may 5 be waived. 6 [<u>NEW MATERIAL</u>] NURSING STAFFING LEVELS.--7 SECTION 6. Nursing staffing levels shall take into 8 Α. 9 consideration: recommendations from the hospital's chief 10 (1)nursing officer, direct patient care nurses, ancillary staff, 11 12 professional nursing organizations and other appropriate 13 resources as determined by the committee; 14 (2) the characteristics of patients in each unit, including patient acuity as well as variability in the 15 number of discharges, admissions and transfers per shift; 16 available medical and health information 17 (3) 18 technology and systems resources; 19 (4) the education, training and experience of 20 nurses who provide direct patient care for the purpose of staffing a unit with an equal mix of more-experienced and less-21 experienced nurses; and 22 such other appropriate factors as 23 (5) determined by the committee. 24 Nursing staffing levels for each unit shall be 25 B. .195860.1 - 4 -

1 determined by majority vote of the committee. 2 C. A hospital shall formulate and adopt an 3 algorithm for maintaining nursing staffing levels determined by the committee, which may require the hiring of additional 4 5 nurses. A hospital shall not achieve nursing staffing 6 D. 7 levels with mandated overtime. [NEW MATERIAL] RIGHT TO REFUSE ASSIGNMENT.--A 8 SECTION 7. 9 nurse may refuse an assignment if: the nurse lacks the requisite education, 10 Α. training and experience to ensure patient safety; or 11 12 Β. the assignment is outside the nurse's scope of 13 practice. 14 SECTION 8. [NEW MATERIAL] HOSPITAL POSTING AND REPORTING OF NURSING STAFFING LEVELS .--15 Within one hour of the start of each shift, a 16 Α. 17 hospital shall conspicuously post a daily report in each of its 18 units, next to posted patient rights, that contains the: 19 (1) actual patient census for each shift in 20 that unit; staffing level for each shift, according 21 (2)to the staffing plan for such unit; and 22 actual staffing level for each shift in 23 (3) that unit. 24 The daily report shall include nurses and 25 Β. .195860.1 - 5 -

C. On a quarterly basis, a hospital shall
electronically submit to the department for public disclosure
on the department's web site, on a date and in a format and
form prescribed by the department, an accurate report
containing the:

(1) information required in Subsection A of this section for each day of the previous quarter; and

9 (2) number of daily admissions, discharges and10 transfers for each shift of each unit.

SECTION 9. [<u>NEW MATERIAL</u>] DUTIES OF DEPARTMENT.--The department shall:

A. prescribe the format, form and due date for a hospital's quarterly submission of the report required of a hospital pursuant to Subsection C of Section 8 of the Safe Staffing Act. The department shall require information contained in each hospital's quarterly reports to be reported in a uniform and clearly understandable format that permits consumers of hospital services to make meaningful comparisons of nursing staffing levels;

B. promptly publish each quarterly report required of a hospital pursuant to Subsection C of Section 8 of the Safe Staffing Act on its internet web site for public inspection;

C. periodically audit the information contained in a quarterly report required of a hospital pursuant to .195860.1

Subsection C of Section 8 of the Safe Staffing Act;

2 D. enforce a hospital's compliance with the 3 provisions of the Safe Staffing Act and with any related rules promulgated by the department to implement the provisions of 4 that act through the imposition of penalties and corrective 5 action, which information shall also be published on the 6 7 department's web site proximate to the quarterly reports required pursuant to Subsection C of Section 8 of the Safe 8 Staffing Act; and 9

E. promulgate such rules as are necessary to implement and enforce the provisions of the Safe Staffing Act.

SECTION 10. [<u>NEW MATERIAL</u>] WHISTLEBLOWER PROTECTION.--A hospital shall not discriminate or retaliate in any manner against an employee as a result of a grievance or complaint initiated by the employee relating to:

A. a committee or plan;

B. the posting or reporting of, or the failure to post or report, daily nursing staffing level information required by the Safe Staffing Act; and

C. the exercise of the right to refuse an assignment pursuant to the Safe Staffing Act.

SECTION 11. APPROPRIATION.--

A. One hundred thousand dollars (\$100,000) is appropriated from the general fund to the department of health for expenditure in fiscal year 2015 to undertake the duties and .195860.1
