I request that the following be funded:

NM STATE LIBRARY BOOKMOBILE

three hundred thousand dollars (\$300,000) to purchase, design and construct a bookmobile vehicle for the New Mexico state library

SOCORRO CSD ACTIVITY BUS

one hundred seventy thousand dollars (\$170,000) to purchase and equip an activity bus for the Socorro consolidated school district in Socorro county

- to the department of environment

RESERVE WASTEWATER SYSTEM IMPROVE

five hundred thousand dollars (\$500,000) to design, construct and equip improvements to the wastewater treatment system in Reserve in Catron county

MAGDALENA WELL AND WATER SYSTEM IMPROVE

three hundred thirty-six thousand dollars (\$336,000) to design and construct supplemental well and water system improvements in Magdalena in Socorro county

SOCORRO WWATER TREATMENT PLANT/COLLECTION SYSTEM

one million four hundred thousand dollars (\$1,400,000) to design, construct, expand and equip the wastewater treatment plant and wastewater collection system in Socorro in Socorro county

seventy-five thousand dollars (\$75,000) to purchase and install information technology, including related furniture, equipment and infrastructure, for a jail management and record system in the county detention center in Socorro in Socorro county

two hundred thousand dollars (\$200,000) to construct phase 3 improvements to the community center and commercial kitchen in Sabinal in Socorro county

one hundred thousand dollars (\$100,000) to design and construct phase 1 improvements to roof and drainage systems at the county courthouse in Socorro in Socorro county

one hundred seventy-two thousand six hundred forty-two dollars (\$172,642) to plan, design, construct and install improvements, including lighting, to the Manzano expressway from Van Camp boulevard to south Rio del Oro in Valencia county
