#### **SUMMARY**

Synopsis of Bill

House Bill 172 appropriates \$75 thousand from the general fund to Mesalands Community College (MCC) for the purposes of supporting the college's athletic programs.

## FISCAL IMPLICATIONS

As drafted, the appropriation of \$75 thousand contained in this bill is a recurring expense to the general fund. Any unencumbered balance remaining at the end of FY15 shall revert to the general fund. However, MCC has consistently received general fund appropriations for athletics in HB 2.

#### House Bill 172 – Page 2

Should the appropriation in this bill be included in HB 2, Section 4, the funds would likely be treated as a recurring general fund appropriation. (The tables of this FIR treat the appropriation in HB 172 as a recurring appropriation.)

In FY14, MCC received a \$59.9 thousand general fund appropriation to fund its athletic programs, including its nationally-known rodeo program. For FY15, HED requested and the LFC and Executive recommended a general fund appropriation of \$59.9 thousand. Should HB 172 and either budget recommendation be enacted, the MCC athletics program would receive \$134.9 thousand in general fund revenues, a 125 percent increase over the FY14 general fund level.

### **SIGNIFICANT ISSUES**

The National Intercollegiate Rodeo Association (NIRA) recognizes MCC's rodeo program as one of the country's best. Both the men's and women's teams and individual riders regularly earn top rankings in regional and national competitions and earn academic-athletic honors. MCC has hosted five annual community college rodeo competitions. The college also offers a number of athletic scholarships for equestrian sports, including rodeo.

### **ADMINISTRATIVE IMPLICATIONS**

Additional general fund support would not add an administrative burden for MCC.

#### **DUPLICATION**

HB 172 duplicates an appropriation to MCC's athletic program in the General Appropriation Act (HB 2).
