SUMMARY

Synopsis of Bill

Senate Bill 620 appropriates \$1.5 million from the general fund to HSD to contract for behavioral health services in McKinley.

FISCAL IMPLICATIONS

Senate Bill 620 – Page 2

The appropriation of \$1.5 million contained in this bill is a recurring expense to the general fund. Any unexpended balance remaining at the end of fiscal year 2016 shall revert to the general fund.

SIGNIFICANT ISSUES

HSD points that that similar to many other New Mexico counties, the need for behavioral health services in McKinley County is substantial. The New Mexico Department of Health (DOH) reported in 2014 that McKinley County residents ranked second in the state for 2008-2012 by rates per capita for alcohol-related death overall, alcohol-related chronic disease deaths, and alcohol-related injury, and they ranked fourth for alcohol-related crashes, sixth for suicide, and twenty-first for frequent mental distress rates.

SB 620 would provide additional funding beyond current levels. Other current funding sources in the County include Medicaid, federal Mental Health Block Grants, federal Substance Abuse Prevention Block Grants, Corrections Department, Children, Youth and Families Department, the Administrative Office of the Courts, Medicare, the Veterans' Administration, Gallup and McKinley County governments, local school districts, the Navajo Nation, and portions of State General Fund appropriations for behavioral health services that did not restrict the target geographic area. Under the federal Affordable Care Act, private insurance policies also now must cover behavioral health services for their beneficiaries.

SB 620 does not specify that services in the county shall go only to county residents, so residents of other areas might also benefit from increased behavioral health services in McKinley County.

ALTERNATIVES

McKinley County would likely benefit from additional resources under the passage of HB 108 (or similar bills such as SB522, SB566, and SB666) that aim to direct mental health funding to certain "investment zones" where behavioral health service needs are high.
