SUMMARY

Synopsis of Bill

Senate Bill 126 appropriates \$50 thousand from the general fund to the Governor's Commission on Disability for the purpose of funding a dance program for people with disabilities.

FISCAL IMPLICATIONS

GCD estimates an agency cost of \$2,500.00 to administer the program, which would include time spent reviewing the contracting process, reviewing deliverables, processing payments and making site visits. The bill makes no mention as to whether the funding can be used for the agency's administrative expenses.

Senate Bill 126 – Page 2

The appropriation of \$50 thousand contained in this bill is a recurring expense to the General Fund. Any unexpended or unencumbered balance remaining at the end of Fiscal Year 2017 shall revert to the General Fund.

SIGNIFICANT ISSUES

The National Endowment for the Arts funds a program for dancers with disabilities, many in wheelchairs, which it states (<u>https://www.arts.gov/NEARTS/2014v3-healing-properties-art-health/dancing-disability</u>) benefits the dancers in their recovery from injury or acceptance of on-going disabilities. That program is distinct from dance therapy, which is often applied with adults and children with disabilities as an enjoyable and soothing activity. Albuquerque's North Fourth VSA has a program called Buen Viaje Dance Group largely devoted to dancers with disabilities.
