Synopsis of Bill

Senate Memorial 35 (SM35) notes the U.S. Department of Transportation and U.S. Office of the Surgeon General identify "Complete Streets" as:

- Streets designed and operated to enable safe use and mobility for all users, including people of all ages and abilities, regardless of whether they are traveling as drivers, pedestrians or bicyclists or riding on public transportation; and
- Streets that promote walking and walkable communities by improving access to safe and convenient places to walk, noting that one out of every two U.S. adults is living with a chronic disease, such as heart disease, cancer or diabetes.

The memorial recognizes and congratulates the leadership and accomplishments of local and tribal governments, and requests copies of the memorial be transmitted to the team members of New Mexico "Complete Streets" including the:

- New Mexico Department of Transportation,
- Department of Health,
- State Transportation Commission,
- Tribal liaison for the New Mexico Department of Transportation,
- Division administrator of the New Mexico division of the Federal Highway Administration,
- Energy, Minerals and Natural Resources Department;
