SUMMARY

Synopsis of Bill

House Bill 1 appropriates money from the general fund, other state funds, internal services funds/interagency transfers, and federal funds for FY18 for the operation of legislative agencies and higher education institutions in fiscal year 2018. The appropriations in the bill generally reflect vetoed items in the 2017 General Appropriation Act (House Bill 2).

House Bill 1 appropriates \$208.8 thousand from legislative cash balances to various legislative agencies for the purpose of funding the necessary expenses of the First Special Session of the Fifty-Third Legislature.

Recurring general fund appropriations total \$763.8 million, a decrease of \$7.3 million, or -0.9 percent, from the adjusted FY17 level.

FISCAL IMPLICATIONS

Appropriations totaling \$763.8 million include \$19 million for legislative offices and other interim expenses and \$744.8 million for higher education institutions and are a recurring expense to the general fund for FY18.

Nonrecurring special appropriations totaled \$3.65 million, including general fund appropriations of \$400 thousand for a tax study, \$150 thousand for a Capital Buildings Planning Commission Master Plan, \$99.6 thousand for National Center for State Court dues, and \$500 thousand for student financial aid. Other state funds appropriations total \$2.5 million and include \$1 million from legislative cash balances for repairs, security, and infrastructure upgrades in the Capitol building, \$1 million from University of New Mexico unrestricted cash balances for the Cancer Center at the Health Sciences Center, and \$500 thousand from cash balances in the special programs fund of the Higher Education Department for student financial aid. The bill also includes a contingent special appropriation of \$26.4 million for hospital provider rate increases in Medicaid from County Supported Medicaid funds.

The bill allows the Public Education Department (PED) to increase the preliminary unit value by up to \$16.00 for FY18. Often, the preliminary unit value is adjusted in the second half of the school year, and school districts receive a supplementary distribution from the final unit value. Despite student membership data indicating a decrease in total units for FY18, PED projected an increase in FY18 total units when setting the preliminary unit value. Analysis indicates the preliminary 2017-2018 unit value and number of units set by PED could be adjusted to distribute \$10 million earlier in the school year to school districts statewide. Language in the bill authorizes the department to use cash balances in the state-support reserve fund and up to \$10 million from the general fund operating reserve to address potential shortfalls resulting from the additional \$16.00 unit value increase.

Also included is a \$1.2 million supplemental appropriation to the Administrative Office of the Courts for fiscal year 2017 shortfalls in magistrate courts.

The appropriation of \$208.8 thousand in other state funds contained in this bill is to fund the expenses of the First Special Session of the Fifty-Third Legislature and is a nonrecurring expense from legislative cash balances. The funds are appropriated as follows:
