HOUSE EXECUTIVE MESSAGE NO. 152

The Honorable Brian Egolf, Jr., Speaker of the House and Members of the House of Representatives State Capitol Building Santa Fe, NM 87501

Honorable Speaker Egolf and Members of the House:

For the eighth straight year, the capital outlay bill passed by the Legislature contains some of the same pork projects that continue to trouble the state of New Mexico. These projects do not create jobs, nor have a lasting impact on our economy.

As I've stressed time and again, capital outlay funding should always be used for projects that create jobs, address critical infrastructure needs, and have a long-term positive economic impact. State resources should be focused on projects which are too expensive for a local entity to remedy, or are potentially disruptive to public life and public safety. Instead, as evidenced by many of the projects included in this bill, the Legislature continues to support projects that will sit idle because they are poorly funded, planned, vetted, or titled.

Once again, the Legislature refused to approve legislation that would ensure public funds are spent effectively and efficiently. Not only does the Legislature refuse to address the weaknesses in the current system, but it also chooses to hide the way each legislator allocates capital dollars. It is unfortunate that our legislative body does not see fit to enforce upon itself the level of transparency it so frequently demands of other governmental agencies. Despite best efforts, legislation intended to increase needed transparency continues to stall.

The Department of Finance and Administration, in collaboration with the Legislative Finance Committee, reviewed a large number of projects that have had no activity, as far back as 2004. As a result, 112 projects, totaling almost \$11 million dollars, were swept and used to address solvency needs. Last year, more projects were presented to the State Board of Finance, which approved the reassignment of 25 project bond proceeds to projects considered shovel-ready. The total amount of reassigned projects was \$1.6 million dollars.

Because the Legislature refuses to support necessary changes, I have been forced to ensure that scarce capital dollars are spent effectively and efficiently. It is imperative to safeguard public funds and ensure expenditure within the timeframe identified in legislation. Administrative improvements made so far include:

- Executive Order 2013-006, which requires that entities be compliant with the Audit Act and its reporting requirements;
- Anti-donation clearance protocol;
- Enforcement of monthly reporting requirements; and
- Concurrent bill review and the bond questionnaire processes.

State projects, higher education institutions, and aging projects go through a rigorous vetting process. The state facility priority projects in this bill include:

- Funding for security systems in schools statewide;
- Critical upgrades to corrections, CYFD, health facilities, national guard facilities, and state police;
- Watershed and forest-thinning to protect communities and environments;
- A new helicopter for State Police for search and rescue;
- New school buses for students in every corner of the state;
- Public safety telecommunications; and
- Construction of a new Vital Records Office to meet the demands of Real ID.

This bill has a number of projects in which local entities cannot demonstrate that tax payer dollars are protected from fraud and abuse.

A number of legislators chose to pool their individual capital funding allocations to complete large-scale projects. A couple of examples include \$1.9 million for New Mexico Highway 347 in Sandoval and Bernalillo Counties, and \$2.5 million for a bridge replacement in San Juan County. These legislators should be applauded for funding projects that will have a lasting positive impact in their communities.
