I have this day SIGNED SENATE FINANCE COMMITTEE SUBSTITUTE FOR SENATE BILL 245, with emergency clause, enacted by the Fifty-Third Legislature, Second Session, 2018, except the following part or parts, item or items, which I have vetoed pursuant to Article IV, Section 22 of the Constitution of the State of New Mexico:

On page 8, I have vetoed all of lines 6 through 19.

Beginning on page 10, I have vetoed all of lines 24 and 25, and on page 11, I have vetoed all of lines 1 through 11.

On page 12, I have vetoed all of lines 16 through 23.

Beginning on page 12, I have vetoed all of lines 24 and 25, and on page 13, I have vetoed all of lines 1 through 7.

On page 19, I have vetoed all of lines 8 through 16.

On page 25, I have vetoed all of lines 9 through 19.

On page 28, I have vetoed all of lines 12 through 23.

On page 31, I have vetoed all of lines 6 through 23.
