SECTION 1. [<u>NEW MATERIAL</u>] SHORT TITLEThis act may be
cited as the "Hepatitis C Registry Act".
SECTION 2. [<u>NEW MATERIAL</u>] DEFINITIONSAs used in the

[<u>NEW MATERIAL</u>] UNIVERSITY OF NEW MEXICO HEALTH 5 SCIENCES CENTER--HEPATITIS C REGISTRY .-- The "hepatitis C 6 7 registry" is created at the clinical and translational science 8 center of the university of New Mexico health sciences center. 9 The center shall use the registry to monitor and measure 10 progress in hepatitis C elimination among New Mexico residents 11 statewide, including the number of individuals tested, treated 12 and cured of hepatitis C and related conditions. The center 13 shall use the registry to store the following information: 14 Α. demographic information relating to individuals exposed to the hepatitis C virus, including each individual's: 15 16 (1)age; gender; 17 (2) 18 (3) ethnicity;

[NEW MATERIAL] REGISTRY DIRECTOR--ACCESS--STANDARD OPERATING PROCEDURES .--13 14 Α. The chancellor shall appoint a director of the registry. Access to the registry shall be limited to: 15 individuals and entities that the 16 (1)chancellor approves for access; and 17 18 (2) the hepatitis C research group of the 19 university of New Mexico health sciences center. 20 Β. The director shall establish standard operating procedures for access to and use and storage of information in 21 the registry. 22 [NEW MATERIAL] HEPATITIS C REGISTRY FUND--SECTION 5. 23 CREATION.--The "hepatitis C registry fund" is created in the 24 25 state treasury. appropriations. Money in the fund shall not revert to any other fund at the end of a fiscal year. The board of regents of the university of New Mexico shall administer the fund, and money in the fund is appropriated to the board of regents of the university of New Mexico to carry out the provisions of the Hepatitis C Registry Act. Money in the fund shall be disbursed on warrants signed by the secretary of finance and administration pursuant to vouchers signed by the board of regents of the university of New Mexico or the board's authorized representative. - 4 -.209422.3
