thirteen million five hundred seventy-seven thousand nine hundred seventy-six dollars (\$13,577,976) to plan, design and construct a dam on Spring canyon west of Hatch in Dona Ana county

• to the department of environment

LAS CRUCES FLOOD CONTROL FCLTY CONSTRUCT

seventy-five thousand dollars (\$75,000) to plan, design and construct flood control facilities in Las Cruces in Dona Ana county

• to the local government division of the department of finance and administration

DONA ANA CO FAIRGRNDS IMPROVE

three hundred fifty thousand dollars (\$350,000) to plan, design and construct improvements, including electrical, plumbing and sidewalks, at the Dona Ana county fairgrounds in Dona Ana county
