SUMMARY

Synopsis of HEC Amendment

The House Education Committee amendment to House Bill 464 reduces the service commitment for a teacher, who received support according to the bill, from four years of service down to two years of service. Each teacher would receive \$25,774 (approximate) in state support and be required to teach in a New Mexico public school for two years.

Synopsis of Original Bill

House Bill 464 appropriates \$300 thousand from the general fund to for the purpose of paying for tuition and fees for 50 students, who enroll in the College of Education to pursue a path to obtain a teaching degree. The bill establishes requirements for students who apply for admissions at ENMU, requiring at least a 3.3 GPA and a minimum ACT score of 24. ENMU is required to select the fifty students to mirror the demographic makeup of the current ENMU student body. For those students who are awarded the funding under HB464, the student would be required to teach in a New Mexico public school for at least 4 years.

FISCAL IMPLICATIONS

Tuition and fees at Eastern New Mexico University (ENMU) for the 2018-2019 academic year totals: \$6,206.64/year. The total tuition and fees cost for 50 students would total \$310,350, with the assumption that ENMU could fill all 50 slots. If all students enrolled, ENMU would generate an additional \$389 thousand in revenue from residence hall and meal plan fees, and from estimated books and supplies for the student cohort.

The appropriation of \$300 thousand contained in this bill is a recurring expense to the general fund. Any unexpended or unencumbered balance remaining at the end of FY20 shall not revert to the general fund.

SIGNIFICANT ISSUES

In 2017, ENMU graduated 61 students in its college of education. Neither ENMU nor HED provided data regarding implementation for HB464 to determine the impact of the constraints, detailing how many students could meet the requirements. The table below provides the number of graduates at ENMU's College of Education:

ADMINISTRATIVE IMPLICATIONS

Enactment of HB464 will have an administrative impact on ENMU, who would be required to develop a system for determining the application of the appropriation to students who are being admitted in the Academic Year (AY) 2020 cycle. Additionally, HB464 requires the eligible student to commit to teaching in a public school in New Mexico for at least 4 years. ENMU would be required to develop a commitment agreement and track the graduates to ensure compliance with the law.

Implementing the provisions of HB464 will create duplication for ENMU, given that many students who enroll in a four-year degree program at ENMU, and who are from New Mexico, would be eligible for the Lottery Scholarship Program. At ENMU, the lottery scholarship has an approximate value of \$3,000 per year.

CONFLICT, DUPLICATION, COMPANIONSHIP, RELATIONSHIP

HED administers several student financial aid programs, which accomplish a similar goal to HB464. Specific to teaching, HED manages a teacher-loan-for-service program and a teacher loan repayment program.

In the FY20 LFC Appropriation Recommendation, \$25 million is appropriated for the Teacher Loan Repayment Program.

OTHER SUBSTANTIVE ISSUES

New Mexico is experiencing a severe shortage of teachers within its public school system. This shortage has become so significant and pervasive that school districts are recruiting public school teachers from foreign countries. ENMU believes a scholarship program that pays for tuition/fees for students to attain a Teacher Education degree will attract more students to seek this career path.
