SUMMARY

Synopsis of Bill

Senate Bill 104 proposes a \$20.00 fee in addition to the regular motor vehicle registration fee for a new miner's license plate of which \$10.00 would be earmarked and appropriated to TRD for the manufacture and issuance of the license plate, and \$10.00 would be earmarked and appropriated to Miners' Hospital of New Mexico in Raton to be used for chronic illness research.

The effective date of the bill is July 1, 2019.

FISCAL IMPLICATIONS

TRD assumes 75 Miners License Plates being would be issued annually with a projected total revenue increase of \$1.5 thousand annually, with TRD receiving half of this revenue, or \$750.00, and Miners' Hospital receiving \$750.00 annually.

TRD notes the cost to design and implement a new license plate is \$100.00 to design a plate and \$500.00 for the initial order of 100 plates, for a total of \$600.00.

SIGNIFICANT ISSUES

Miners' Hospital reports it does not have a research department or conduct any research functions and would be unable to use the funds provided for in the bill for chronic illness research, but would rather be able to use the funds to conduct outreach activities to miners' to further access treatment under Miners' Hospital's federal Black Lung Program.

ADMINISTRATIVE IMPLICATIONS

TRD reports under the provisions of the bill there would be minimal non-recurring administrative impact for the Motor Vehicle Division (MVD). A new special plate application form will be required as well as an update to the special plates section of the policy manual, and staff training totaling approximately \$33.6 thousand.
