## SUMMARY

#### Synopsis of Senate Public Affairs Amendment (SPAC)

Senate Bill 211/aSPAC amends the original bill to add clarifying language to ensure the use of the appropriation to Project Echo for assisting underserved rural, urban and medicaid patients.

#### Synopsis of Bill

Senate Bill 211 appropriates \$2 million from the general fund to University of New Mexico's Health Science Center to increase funding for Project ECHO (Extension for Community Healthcare Outcomes) Health Program.

## FISCAL IMPLICATIONS

According to HED, Project ECHO's annual operating budget is \$18 million, which includes \$2,046,100 from state general fund appropriations. The requested funding in SB211 will allow Project ECHO to continue to address its mission, which is improve health outcomes for rural and

underserved New Mexicans.

Project ECHO is a program within the UNM HSC School of Medicine. The FY20 LFC recommendation increases the budget for Project ECHO by 7.3 percent.

The appropriation of \$2 million contained in this bill is a recurring expense to the general fund. Any unexpended or unencumbered balance remaining at the end of FY20 shall revert to the general fund.

#### SIGNIFICANT ISSUES

Since its inception in 2003, Project ECHO has grown substantially. Initially, this program worked with hepatitis C patients throughout the state. The model incorporates a virtual mentoring platform which increases access to specialty treatment in rural and underserved areas by providing local clinicians with the knowledge and support they need to manage patients with complex conditions such as: hepatitis C, HIV, tuberculosis, chronic pain, endocrinology, behavioral health disorders, and many others. The model allows for local clinicians the ability to engage in a continuous learning system by partnering them with specialist mentors at an academic medical center or hub.

## **PERFORMANCE IMPLICATIONS**

SB211 does not contain performance measures.

## CONFLICT, DUPLICATION, COMPANIONSHIP, RELATIONSHIP

Senate Bill 209 also makes an appropriation to Project ECHO for \$1.1 million. SB211 would add \$2 million to the existing operating budget for Project ECHO.

## **TECHNICAL ISSUES**

SB211 contains reversion language, where unexpended balances from the appropriation revert to the general fund. Higher education institutions, which includes UNM HSC Project ECHO, do not revert unexpended balances.

## **OTHER SUBSTANTIVE ISSUES**

Every year, HED and LFC staff conduct hearings with research and public service projects (RPSPs) to receive the next fiscal year funding requests. Project ECHO did not submit a request for additional funding. The LFC FY20 budget recommendation increased the request by \$150,000 over the FY19 level. The FY20 Executive recommendation for Project ECHO is \$2,046,100 (flat with FY19).
