SUMMARY

Synopsis of Bill

Senate Bill 436 is related to special property tax districts; expands the term and increases the amount of a potential levy assessed by a soil and water conservation district (SWCD). This bill amends Section 73-20-46 NMSA 1978 to increase the amount a SWCD may levy from one dollar (\$1.00) to five dollars (\$5.00) per thousand dollars (\$1,000) of net taxable value. Further, this bill eliminates the sunset clause that limits the levy to ten years and strikes additional language related to the sunset clause. The new rate is not subject to the yield control statute. There is no effective date of this bill. It is assumed that the effective date is 90 days after this session ends.

FISCAL IMPLICATIONS

This bill has no fiscal impact to the general fund. There would be increased revenues to soil and water conservation districts if members of the district chose the levy. See table below for SWCDs that currently levy an operating tax. For comparison, the rates levied by watershed districts and conservancy districts are also shown.

SIGNIFICANT ISSUES

The New Mexico Department of Agriculture (NMDA), in its analysis of the vetoed 2018 SB-169, indicated that this bill brings the soil and water conservation district levy in line with other levies assessed by similar districts, such as Watershed Districts (Section 73-20-17 NMSA 1978) and Conservancy Districts (Section 73-16-2 NMSA 1978).

All of the current SWCD levies appear to have been imposed at \$.25, \$.50 or \$1 per \$1,000 of assessed value. Declaring these levies subject to yield control (Section 7-37-7.1 NMSA 1978) was amended out of the statute in 2009. Since this restriction has not been explicitly reinstated for the new levies, LFC staff are of the opinion that yield control reductions will not be required.

From the compiler's notes, "the 2009 amendment to 73-20-46 NMS 1978, effective June 19, 2009, in Subsection A, after "not exceeding one dollar (\$1.00)", deleted "or any lower maximum amount required by operation of the rate limitation provisions of Section 7-37-7.1 NMSA 1978."

DFA describes yield control as follows:

Section 7-37-7.1 NMSA 1978 ("Additional limitations on property tax rates") is commonly referred to as the "yield control statute" because it limits revenue yields that result when property values are increased due to reassessment. ... It is applied separately to residential and non-residential properties.
