SUMMARY

Synopsis of SRC Amendment

The Senate Rules Committee Amendment to Senate Bill 469 strikes language in section 1 regarding the acquisition of right to “Chile Verde Rock.”

The amendment inserts new section clarifying the effective date as July 1, 2019, *and* when the rights of the song are donated to the state.

The Department of Cultural Affairs will oversee the donation and notify the New Mexico Compilation Department when the rights are transferred to the state.

Synopsis of Original Bill

Senate Bill 469 creates a new section of Chapter 12, Article 3 NMSA 1978 to add “Chile Verde Rock” as the state chile song. The bill also provides lyrics for the song.

FISCAL IMPLICATIONS

This bill states New Mexico would acquire “ownership and copyright or perpetual license” of

“Chile Verde Rock”. The song has been registered with the United States Copyright Office and prices would have to be negotiated with the current owner, Uvaldo Eloy Olonia.¹

SIGNIFICANT ISSUES

Currently, every state has a state song. section 12-3-5 NMSA 1973 has the words and music of the song written by Elizabeth Garrett, entitled, "O, Fair New Mexico", as the state song.

Section 12-3-6 NMSA 1973 makes the words and music of "Asi Es Nuevo Mejico," written by Amadeo Lucero, the Spanish language state song.

Though not a song, section 12-3-10 NMSA 1973 makes the words and music of "Land of Enchantment - New Mexico", written by Michael Martin Murphy, Chick Raines and Don Cook, the official state ballad.

Section 12-3-12 NMSA 1973 adopts the words and music of "New Mexico -- Mi Lindo Nuevo Mexico", written by Pablo Mares, as the state bilingual song.

Section 12-3-19 NMSA 1973 has the words and music of "Under New Mexico Skies", written by Syd Masters, be the official state cowboy song.

RELATIONSHIP

Senate Bill 386 amends section 12-3-4 NMSA 1978 to adopt the wedding dance, “La Marcha de Los Novios”, as the state dance of the state of New Mexico. Both bills would add a new state symbol.

In 2017, Senator Campos proposed “Chile Verde Rock” as the official state chile song in SM126, though it died in committee.

WHAT WILL BE THE CONSEQUENCES OF NOT ENACTING THIS BILL

New Mexico would have no state chile song.
