### SUMMARY

#### Synopsis of Bill

Senate Joint Memorial 5 requests a task force composed of representatives from the Department of Cultural Affairs, the county of Santa Fe, the Hispano Round Table of New Mexico, the New Mexico League of United Latin American Citizens, and the Historical Society of New Mexico be convened to plan the development of an American Civil War memorial to be placed at the Glorieta Pass battle site.

The task force will report its findings and make recommendations to the appropriate interim committee at the committee's November 2019 meeting.

### FISCAL IMPLICATIONS

SJM5 will not have a fiscal impact on the operating budget of the Cultural Affairs Department. Current staff at the department will perform required duties in SJM5 in addition to current job duties.

## **Senate Joint Memorial 5 – Page 2**

The Glorieta Pass battlefield is managed by the Pecos National Historical Park. The National Park Service is not a member of the task force.

Pursuant to Section 106 of the National Historic Preservation Act, the Pecos National Historical Park has the responsibility for consulting the State Historic Preservation Office/Historic Preservation Division for any proposed project on federal land, using federal money, or requiring a federal permit or license. On December 2016, the Pecos National Historical Park submitted plans for the installation of a new civil war monument between two existing civil war monuments in the Pigeon's Ranch Sub-unit. These plans included the dimensions of the new monument as well as the location of the new monument. HPD concurred with the Pecos National Historical Park that the installation would have no adverse effect on historic properties, but it is not known if the installation has occurred as planned. Senate Joint Memorial 5 may be in conflict, duplicate or overlap the plans already developed by the Pecos National Historical Park.

### **TECHNICAL ISSUES**

DCA suggests the National Park Service also be represented on the task force.
