WHEREAS, Cibola county is home to six places on the national register of historic places; and

WHEREAS, the Cibola communities economic development foundation, incorporated, which, in 1994, grew out of the greater Grants industrial development foundation, incorporated, founded in 1982, promotes the economic and industrial base of Cibola county and its communities; and

WHEREAS, Antonio Esparza served as the first president of the Cibola communities economic development foundation, incorporated; and

WHEREAS, the board of directors of the Cibola communities economic development foundation, incorporated, consists of fifteen members who, together, represent Cibola county, the city of Grants, the village of Milan, Cibola foundation, incorporated, the Grants/Cibola county chamber of commerce, the Grants-Cibola county school district, New Mexico state university-Grants and private industry;
