#### **SUMMARY**

#### Synopsis of Bill

House Bill 296 appropriates \$250 thousand from the general fund to New Mexico Institute for Mining & Technology (NMIMT) for mathematics, engineering and science pre-college programs that prepare students for college and careers in mathematics, engineering, science or technically related fields through after school and summer enrichment.

## **FISCAL IMPLICATIONS**

The appropriation of \$250 thousand contained in this bill is a recurring expense to the general fund. Any unexpended or unencumbered balance remaining at the end of fiscal year 2021 shall revert to the general fund.

### SIGNIFICANT ISSUES

New Mexico Mathematics, Engineering and Science Achievement (NM MESA or simply MESA) is a pre-college program that prepares students for college and careers in mathematics, engineering, science or technically related fields. MESA supports student programs in middle and high schools throughout New Mexico. MESA students participate in math, science and engineering activities which include field trips, speakers, workshops, academic competitions, community service, and leadership development projects. Additionally MESA has awarded over \$130 thousand in merit based financial aid.

MESA is coordinated through six regional offices which are hosted at a local higher education institution: University of New Mexico, Highlands University, UNM Gallup, New Mexico State University, Santa Fe Community College, and Eastern New Mexico University Roswell.

According to NMIMT's fiscal year 2021 budget expansion request submitted to HED, the funding contained in HB296 would be used as shown in the following table:

# **TECHNICAL ISSUES**

HB296 contains reversion language, where unexpended balances from the appropriation revert to the general fund. Higher education institutions, which includes NMIMT, do not revert unexpended balances.
