AN ACT

RELATING TO STATE AGENCIES; PROVIDING NEW SUNSET DATES FOR  
CERTAIN AGENCIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. A new Section 9-15-51.1 NMSA 1978 is enacted  
to read:

"9-15-51.1. TERMINATION OF AGENCY LIFE--DELAYED  
REPEAL.--The office of military base planning and support and  
the military base planning commission are terminated on  
July 1, 2027 pursuant to the provisions of the Sunset Act.  
The office and the commission shall continue to operate  
according to the provisions of Sections 9-15-48 through  
9-15-51.1 NMSA 1978 until July 1, 2028. Effective  
July 1, 2028, Sections 9-15-48 through 9-15-51.1 NMSA 1978 are  
repealed."

SECTION 2. Section 61-4-17 NMSA 1978 (being Laws 1979,  
Chapter 77, Section 2, as amended) is amended to read:

"61-4-17. TERMINATION OF AGENCY LIFE--DELAYED REPEAL.--  
The chiropractic board is terminated on July 1, 2027 pursuant  
to the Sunset Act. The board shall continue to operate  
according to the provisions of the Chiropractic Physician  
Practice Act until July 1, 2028. Effective July 1, 2028, the  
Chiropractic Physician Practice Act is repealed."

SECTION 3. Section 61-7A-15 NMSA 1978 (being Laws 1989,

1 Chapter 387, Section 15, as amended) is amended to read:

2 "61-7A-15. TERMINATION OF AGENCY LIFE--DELAYED  
3 REPEAL.--The nutrition and dietetics practice board is  
4 terminated on July 1, 2027 pursuant to the Sunset Act. The  
5 board shall continue to operate according to the provisions  
6 of the Nutrition and Dietetics Practice Act until  
7 July 1, 2028. Effective July 1, 2028, the Nutrition and  
8 Dietetics Practice Act is repealed."

9 SECTION 4. Section 61-9-19 NMSA 1978 (being Laws 1978,  
10 Chapter 188, Section 2, as amended) is amended to read:

11 "61-9-19. TERMINATION OF AGENCY LIFE--DELAYED REPEAL.--  
12 The New Mexico state board of psychologist examiners is  
13 terminated on July 1, 2027 pursuant to the Sunset Act. The  
14 board shall continue to operate according to the provisions  
15 of the Professional Psychologist Act until July 1, 2028.  
16 Effective July 1, 2028, the Professional Psychologist Act is  
17 repealed."

18 SECTION 5. Section 61-9A-30 NMSA 1978 (being Laws 1993,  
19 Chapter 49, Section 30, as amended) is amended to read:

20 "61-9A-30. TERMINATION OF AGENCY LIFE--DELAYED  
21 REPEAL.--The counseling and therapy practice board is  
22 terminated on July 1, 2027 pursuant to the provisions of the  
23 Sunset Act. The board shall continue to operate according to  
24 the provisions of the Counseling and Therapy Practice Act  
25 until July 1, 2028. Effective July 1, 2028, the Counseling

1 and Therapy Practice Act is repealed."

2 SECTION 6. Section 61-10-22 NMSA 1978 (being Laws 1979,  
3 Chapter 36, Section 2, as amended) is amended to read:

4 "61-10-22. TERMINATION OF AGENCY LIFE--DELAYED  
5 REPEAL.--The board of osteopathic medicine is terminated on  
6 July 1, 2027 pursuant to the Sunset Act. The board shall  
7 continue to operate according to the provisions of the  
8 Osteopathic Medicine Act until July 1, 2028. Effective  
9 July 1, 2028, the Osteopathic Medicine Act is repealed."

10 SECTION 7. Section 61-12A-24 NMSA 1978 (being Laws  
11 1996, Chapter 55, Section 24, as amended) is amended to read:

12 "61-12A-24. TERMINATION OF AGENCY LIFE--DELAYED  
13 REPEAL.--The board of examiners for occupational therapy is  
14 terminated on July 1, 2027 pursuant to the provisions of the  
15 Sunset Act. The board shall continue to operate according to  
16 the provisions of the Occupational Therapy Act until  
17 July 1, 2028. Effective July 1, 2028, the Occupational  
18 Therapy Act is repealed."

19 SECTION 8. Section 61-12B-16 NMSA 1978 (being Laws  
20 1984, Chapter 103, Section 17, as amended) is amended to  
21 read:

22 "61-12B-16. TERMINATION OF BOARD--DELAYED REPEAL.--The  
23 advisory board of respiratory care practitioners is  
24 terminated on July 1, 2027 pursuant to the Sunset Act. The  
25 board shall continue to operate according to the provisions

1 of the Respiratory Care Act until July 1, 2028. Effective  
2 July 1, 2028, the Respiratory Care Act is repealed."

3 SECTION 9. Section 61-12C-28 NMSA 1978 (being Laws  
4 1993, Chapter 173, Section 21, as amended) is amended to  
5 read:

6 "61-12C-28. TERMINATION OF AGENCY LIFE--DELAYED  
7 REPEAL.--The massage therapy board is terminated on  
8 July 1, 2027 pursuant to the provisions of the Sunset Act.  
9 The board shall continue to operate according to the  
10 provisions of the Massage Therapy Practice Act until  
11 July 1, 2028. Effective July 1, 2028, Chapter 61, Article  
12 12C NMSA 1978 is repealed."

13 SECTION 10. Section 61-12D-17 NMSA 1978 (being Laws  
14 1997, Chapter 89, Section 17, as amended) is amended to read:

15 "61-12D-17. TERMINATION OF AGENCY LIFE--DELAYED  
16 REPEAL.--The physical therapy board is terminated on  
17 July 1, 2027 pursuant to the Sunset Act. The board shall  
18 continue to operate according to the provisions of the  
19 Physical Therapy Act until July 1, 2028. Effective  
20 July 1, 2028, the Physical Therapy Act is repealed."

21 SECTION 11. Section 61-14B-25 NMSA 1978 (being Laws  
22 1996, Chapter 57, Section 25, as amended) is amended to read:

23 "61-14B-25. TERMINATION OF AGENCY LIFE--DELAYED  
24 REPEAL.--The speech-language pathology, audiology and hearing  
25 aid dispensing practices board is terminated on July 1, 2027

1 pursuant to the Sunset Act. The board shall continue to  
2 operate according to the provisions of the Speech-Language  
3 Pathology, Audiology and Hearing Aid Dispensing Practices Act  
4 until July 1, 2028. Effective July 1, 2028, the  
5 Speech-Language Pathology, Audiology and Hearing Aid  
6 Dispensing Practices Act is repealed."

7 SECTION 12. Section 61-14D-19 NMSA 1978 (being Laws  
8 1993, Chapter 325, Section 19, as amended) is amended to  
9 read:

10 "61-14D-19. TERMINATION OF AGENCY LIFE--DELAYED  
11 REPEAL.--The athletic trainer practice board is terminated on  
12 July 1, 2027 pursuant to the provisions of the Sunset Act.  
13 The board shall continue to operate according to the  
14 provisions of the Athletic Trainer Practice Act until  
15 July 1, 2028. Effective July 1, 2028, Chapter 61, Article 14D  
16 NMSA 1978 is repealed."
