AN ACT

RELATING TO THE REDISTRICTING OF THE SENATE; ESTABLISHING
SENATORIAL DISTRICTS; PROVIDING THE METHOD FOR ELECTING
SENATORS; PROVIDING FOR THE FILLING OF VACANCIES; SETTING
PRECINCTS; FIXING THE NUMBER, RESIDENCE AND TERMS OF SENATORS;
REPEALING AND ENACTING SECTIONS OF THE NMSA 1978.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. [NEW MATERIAL] SHORT TITLE.--This act may be
cited as the "2021 Senate Redistricting Act".

SECTION 2. [NEW MATERIAL] MEMBERSHIP.--The senate is
composed of forty-two members to be elected from districts that
are contiguous and that are as compact as is practicable.

SECTION 3. [NEW MATERIAL] RESIDENCE.--At the time of
filing a declaration of candidacy for the office of senator,
the candidate shall reside in the district for which the

1 candidate files. Thereafter, if a senator permanently removes
2 the senator's residence from or maintains no residence in the
3 district from which the senator was elected, the senator shall
4 be deemed to have resigned, and the senator's successor shall
5 be selected as provided in Section 4 of the 2021 Senate
6 Redistricting Act.

7 SECTION 4. [NEW MATERIAL] ELECTIONS--VACANCIES.--

8 A. Members of the senate shall be elected for terms
9 of four years.

10 B. If a vacancy occurs in the office of senator for
11 any reason, the vacancy shall be filled as follows:

12 (1) for a senate district that is situated
13 wholly within the exterior boundaries of a single county, the
14 board of county commissioners of that county shall appoint the
15 senator to fill the vacancy; and

16 (2) for a senate district situated within two
17 or more counties:

18 (a) the board of county commissioners of
19 each county in the senate district shall submit one name to the
20 governor; and

21 (b) the governor shall appoint the
22 senator to fill the vacancy from the list of names so
23 submitted.

24 C. All appointments to fill vacancies in the senate
25 shall be for a term ending on December 31 subsequent to the

1 next succeeding general election, at which general election a
 2 person shall be elected to fill the remainder of any unexpired
 3 term.

4 D. An appointment to fill a vacancy made before the
 5 general election of 2024 shall be made from the district as it
 6 was described in Section 2-8E-1 NMSA 1978, as established by
 7 the court in *Egolf v. Duran*, D-101-CV-2011-02942 (1st Dist.
 8 Ct., Judgement and Final Order (State Senate Trial) filed
 9 January 25, 2012). On or after the general election of 2024, a
 10 vacancy shall be filled by appointment from the district as set
 11 out in the 2021 Senate Redistricting Act.

12 SECTION 5. [NEW MATERIAL] PRECINCTS.--

13 A. Precinct designations and boundaries used in the
 14 2021 Senate Redistricting Act are those precinct designations
 15 and boundaries established pursuant to the Precinct Boundary
 16 Adjustment Act and revised and approved pursuant to that act by
 17 the secretary of state as of November 30, 2021.

18 B. A board of county commissioners shall not create
 19 any precinct that lies in more than one senate district and
 20 shall not divide any precinct so that the divided parts of the
 21 precinct are situated in two or more senate districts. Votes
 22 cast in any general, primary or other statewide election from
 23 precincts created or divided in violation of this subsection
 24 are invalid and shall not be counted or canvassed.

25 SECTION 6. [NEW MATERIAL] DISTRICTS.--The districts of

8 SECTION 50. TEMPORARY PROVISION--COMPILATION

9 INSTRUCTIONS.--The compiler shall remove from the NMSA 1978 the
10 provisions of Section 2-8E-1 NMSA 1978 (copy of state senate
11 districts established by Judgment and Final Order in *Egolf v.*
12 *Duran*, D-101-CV-2011-02942 (1st Dist. Ct., filed January 25,
13 2012)).

14 SECTION 51. REPEAL.--Sections 2-8D-1 through 2-8D-49 NMSA

15 1978 (being Laws 2002, Chapter 98, Sections 1 through 49) are
16 repealed.
