"[<u>NEW MATERIAL</u>] OFFICE OF CHILD ADVOCATE--CREATED.--The "office of child advocate" is created and is administratively attached to the office of the attorney general pursuant to Section 9-1-7 NMSA 1978. The office shall maintain autonomy over the office's budget and any decisions the office may take."

SECTION 4. A new section of the Children's Code is

"[<u>NEW MATERIAL</u>] STATE CHILD ADVOCATE--APPOINTMENT--DUTIES.--The head of the office is the "state child advocate", who shall be appointed for a term of six years, except that the initial term shall begin on July 1, HFLI=>2024 [HFL1 HFLI=>2023 [HFL1 and shall end on December 31, Hf11=>2024 [Hf11] Hf11=>2023 [Hf11 . The state child advocate may be reappointed to successive terms. An appointed state child advocate shall serve and have all of the duties, responsibilities and authority of that office during the period of time in which the state child advocate is appointed. The governor may remove the state child advocate only for malfeasance, misfeasance or abuse of office. The state child advocate shall oversee the office and assign and distribute the work of the state child advocate."

SECTION 5. A new section of the Children's Code is

DUTIES.--

The "state child advocate selection committee" is created and consists of nine members, including: (1) one member who shall be selected by the president pro tempore of the senate; (2) one member who shall be selected by the minority floor leader of the senate; (3) one member who shall be selected by the speaker of the house of representatives; (4) one member who shall be selected by the minority floor leader of the house of representatives; (5) four members who shall be selected by the governor, no more than two of whom are from the same political party HAFC→and←HAFC HAFC→,←HAFC one of whom shall have specialized expertise in the federal Indian Child Welfare Act of 1978 and the Indian Family Protection Act HAFC→and one of whom shall have lived experience in the foster care or juvenile justice system HAFC ; and (6) a committee chair, whom a majority of the other eight members select and who is: (a) not a candidate for the position of state child advocate; and (b) a person with extensive knowledge of child protective or juvenile justice services.

B. The committee shall meet exclusively for the

The committee shall actively solicit, accept and evaluate applications for the position of state child advocate and may require applicants to submit any information that the committee deems relevant to the consideration of applications. Within ninety days before the date on which the term of a state child advocate ends or no later than thirty days after the occurrence of a vacancy in the state child advocate position, the committee shall convene and, within thirty days after convening, submit to the governor the names of persons who are recommended for appointment to the position by a majority of the committee members.

C. Immediately after receiving nominations for the state child advocate, the governor may make one request of the committee for submission of additional names. The committee shall promptly submit those additional names if a majority of the committee members find that additional persons would be qualified and recommends those persons for appointment as state child advocate. The governor shall fill a vacancy or appoint a successor to fill an impending vacancy in the office of state child advocate within thirty days after receiving final nominations from the committee by appointing one of the persons nominated by the committee.

D. The committee is administratively attached to the office of the attorney general pursuant to the provisions

E. After the initial meeting of the committee, the governor or a majority of the committee members may call subsequent meetings of the committee to nominate persons to fill a current or impending vacancy in the position of state child advocate.

F. The members of the committee shall receive per diem and mileage as provided in the Per Diem and Mileage Act and shall receive no other compensation, perquisite or

(5) investigate and attempt to resolve complaints made by or on behalf of children placed in the custody of the department, receiving services under the supervision of the department, subject to a referral to the department or HAFC→whose parent, guardian or custodian is←HAFC under investigation by the department;

<del>(6) decide, in its discretion, whether to</del> investigate a complaint or refer complaints to another agency for investigation;

(7) upon rendering a decision to investigate a complaint, notify the complainant of the intention to investigate and, if the office declines to investigate a complaint or continue an investigation, notify the complainant that no further action will be taken by the office; (8) update the complainant on the progress of the investigation HAFC→and notify the complainant of the final

(1) adopt and promulgate rules pertaining to the administration of the office and, subject to appropriation, hire and contract for such professional, technical and support staff as needed to carry out the functions of the office; provided that such hiring and contracting shall be without regard to party affiliation and solely on the grounds of competence and fitness to perform the duties of the position. Employees of the office, except the state child advocate, are subject to the provisions of the Personnel Act; and

(2) meet or communicate with any children
placed in the custody of the department, receiving services
under the supervision of the department, subject to a referral
to the department or under investigation by the department."

1978, the Indian Family Protection Act, tribal culture, tribal relations and sovereign nation status;

(4) department policies and procedures, including policies and procedures related to abuse and neglect, out-of-home placement and safety and risk assessments; and

(5) such other matters as the office deems

B. The state child advocate shall develop

<del>procedures for the training and certification of appropriate staff.</del>

C. An officer, employee or other representative of the office shall not investigate any complaint filed with the

office unless that person is certified by the office."

shall not have a conflict of interest with the department or with an entity that provides services to children and families through funds provided by the department relating to the performance of their responsibilities pursuant to the Children's Code. For the purposes of this section, a conflict of interest exists whenever the state child advocate, an employee of the office or a person having a contract with the office:

A. has direct involvement in the licensing, certification or accreditation of a provider or facility delivering services to children and families;

B. has a direct ownership interest in a provider or facility delivering services to children and families;

C. is employed by or participates in the management of a provider or facility delivering services to children and families; or

D. receives or has the right to receive, directly or indirectly, remuneration pursuant to a compensation arrangement with a provider or facility delivering services to children and families."

SECTION 10. A new section of the Children's Code is

"[<u>NEW MATERIAL</u>] INCIDENTS, FATALITIES AND NEAR

FATALITIES.--

A. The department shall provide the office with a

B. The department shall provide the office with a written notification within seventy-two hours of:

(1) a fatality or near fatality of a child in its custody or referred or receiving services under the

supervision of the department; and

(2) the restraint or seclusion of a child in its custody."

SECTION 11. A new section of the Children's Code is

"[<u>NEW MATERIAL</u>] LAW ENFORCEMENT REPORTS.--Upon request by the office, law enforcement agencies shall share with the office all law enforcement reports involving children placed in the custody of the department, receiving services under the supervision of the department, subject to a referral to the department or under investigation by the department."

SECTION 12. A new section of the Children's Code is enacted to read:

"[<u>NEW MATERIAL</u>] CONFIDENTIALITY OF INFORMATION--TESTIMONY OR DISCLOSURE OF EVIDENCE AT A JUDICIAL OR ADMINISTRATIVE HEARING.--

A. The office shall maintain the confidentiality of all case records, third-party records and court records, as

well as any information gathered in the course of investigations and system monitoring duties. These records are exempt from public inspection and copying pursuant to the Inspection of Public Records Act and shall be kept confidential unless:

(1) disclosure is ordered by the court;

(2) disclosure is necessary to prevent

imminent harm and the imminent harm is communicated directly to the state child advocate or staff of the office;

(3) disclosure is necessary to the department in order for the department to determine the appropriateness of initiating an investigation regarding potential abuse or neglect or other emergency circumstances; or

(4) disclosure is necessary to the department in order for the department to determine the appropriateness of initiating an investigation to determine facility compliance with applicable rules of licensure or certification or both.

B. Notwithstanding Subsection A of this section, the office may publicly report any patterns of conduct or repeated incidents identified by the office in carrying out the provisions of the Office of Child Advocate Act; provided that the office shall not publicly disclose either of the following: (1) individually identifiable information

about a child unless the information is already known to the public; and

C. The state child advocate or staff of the office may not be compelled to testify or produce evidence in any judicial or administrative proceeding with respect to any matter involving the exercise of office duties. All related memoranda, work products, notes or case files of the office are confidential and are not subject to discovery, subpoena or other means of legal compulsion and are not admissible as evidence in a judicial or administrative proceeding. However, the state child advocate may provide testimony related to quarterly or annual reports submitted to the legislature, the department or the governor."

SECTION 13. A new section of the Children's Code is enacted to read:

"[<u>NEW MATERIAL</u>] OTHER REMEDIES.--An individual who pursues remedies pursuant to the Office of Child Advocate Act is not precluded from pursuing other legal or equitable remedies."

SECTION 14. A new section of the Children's Code is

"[<u>NEW MATERIAL</u>] NOTIFICATION OF OFFICE OF CHILD ADVOCATE.--The department shall notify all children placed in the custody of the department, receiving services under the supervision of the department, subject to a referral to the department or under investigation by the department and their

SECTION 15. Section 32A-2-32 NMSA 1978 (being Laws 1993, Chapter 77, Section 61, as amended) is amended to read:

"32A-2-32. CONFIDENTIALITY--RECORDS.--

A. All records pertaining to the child, including all related social records, behavioral health screenings, diagnostic evaluations, psychiatric reports, medical reports, social studies reports, records from local detention facilities, client-identifying records from facilities for the care and rehabilitation of delinquent children, pre-parole or supervised release reports and supervision histories obtained by the juvenile probation office, parole officers and the juvenile public safety advisory board or in possession of the department, are confidential and shall not be disclosed directly or indirectly to the public.

B. The disclosure of all mental health and developmental disability records shall be made pursuant to the Children's Mental Health and Developmental Disabilities Act.

C. The records described in Subsection A of this section, other than mental health and developmental disability records, shall be disclosed only to any of the following,

(17) the child, if fourteen years of age or

D. If disclosure of otherwise confidential records is made to the child or any other person or entity pursuant to a valid release of information signed by the child, all victim or witness identifying information shall be redacted or otherwise deleted.

E. Whoever intentionally and unlawfully releases any information or records closed to the public pursuant to this section or releases or makes other unlawful use of records in violation of this section is guilty of a petty misdemeanor.

F. The department shall promulgate rules for implementing disclosure of records pursuant to this section and in compliance with state and federal law and the Children's Court Rules."

SECTION 16. Section 32A-4-33 NMSA 1978 (being Laws 1993, Chapter 77, Section 127, as amended) is amended to read:

"32A-4-33. CONFIDENTIALITY--RECORDS--PENALTY.--

A. All records or information concerning a party to a neglect or abuse proceeding, including social records, diagnostic evaluations, psychiatric or psychological reports, videotapes, transcripts and audio recordings of a child's

(6) any local substitute care review board or any agency contracted to implement local substitute care review boards;
