AN ACT

RELATING TO ELECTED OFFICIALS; INCREASING THE COMPENSATION OF ELECTIVE STATE OFFICERS SFC→WHOSE TERMS BEGIN ON OR AFTER JANUARY 1, 2027←SFC .

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. Section 8-1-1 NMSA 1978 (being Laws 1971, Chapter 260, Section 1, as amended) is amended to read:

"8-1-1. COMPENSATION OF ELECTIVE STATE OFFICERS.--

A. Annual compensation of elective state officers shall be paid as follows:

144,714 ← Sf11

secretary of state \ldots \ldots \ldots \ldots	[85,000] <u>144,714</u>
state auditor	[85,000] <u>144,714</u>
state treasurer	[85,000] <u>144,714</u>
attorney general	[95,000] <u>154,714</u>
commissioner of public lands	[90,000] <u>149,714</u> .

B. Any person succeeding to the office of governor as provided in Article 5, Section 7 of the constitution of New Mexico shall receive the salary of the office. Every person serving as acting governor during the incapacity or absence of the governor from the state Sfll→, other than the secretary of state,←Sfll shall receive SHPAC→two hundred fifty dollars (\$250)←SHPAC SHPAC→five hundred dollars (\$500)←SHPAC as compensation for each day's service as acting governor.

C. All compensation under this section shall be paid from the general fund, except that the amount paid to the commissioner of public lands shall be paid from the state lands maintenance fund."
