#### **SECTION III: NARRATIVE**

#### **BILL SUMMARY**

<u>Synopsis</u>: This bill addresses the behavioral health needs of firefighters and emergency responders by allowing state, local and regional public fire agencies to create peer support programs for their employees and volunteers. The bill will make the peer support services confidential and limit liability for the provision of peer support services. The bill makes an appropriation of \$500,000 to the State Fire Marshal's office to implement the Act in fiscal year 2025.

#### **FISCAL IMPLICATIONS**

#### **SIGNIFICANT ISSUES**

The Forestry Division of the Energy, Minerals and Natural Resources Department is a public fire agency as defined in HB 101, employing wildland firefighters who experience critical incident stress. The Forestry Division currently relies upon federal agency partners and cooperators to provide peer support services for state employees as needed after a critical incident that involves a crisis, disaster, trauma or emergency. Wildfire response is typically an interagency process, and the Forestry Division has accessed the Interior Department and USDA Forest Service joint behavioral health programs after incidents that result in unusually strong emotional, cognitive, behavioral or physical reactions that interfere with normal functioning of employees. HB 101 would help to make these programs and supports more accessible to Forestry's wildland firefighters without having to engage in time-intensive interagency agreements, allowing compassionate response to critical incidents to be immediately available.
