BILL SUMMARY

<u>Synopsis:</u> HB 235 provides exemption from state licensing requirements for child care programs or facilities licensed or certified by the US department of defense or united states coast guard; providing portability of professional licenses for a member of the armed forces or a member's spouse who relocates from another state to new mexico; amends various commission and council memberships to include a member of the armed forces or state defense force, a spouse of a member of the armed forces or state defense force or a veteran; amending sections of the nmsa 1978 to add space force to the definitions of "armed forces" and "uniformed services" that involve programs and services for which members of the armed forces or the armed forces of the united states are eligible; providing for concurrent jurisdiction on violation of laws by a child on military installations.
