BILL SUMMARY

Synopsis: SB 145 prohibits public bodies (or individuals acting on behalf of a public body) from entering into any contracts or agreements to, “detain individuals for federal civil immigration violations.” SB 145 also terminates any already existing public body contracts and agreements to detain individuals for federal civil immigration violation to terminate no later than May 15, 2024 (or as soon as possible for those contracts not containing a termination provision). Furthermore, SB 145 prohibits public bodies from using any resources, including funds or properties, to assist or contribute to the detention of individuals for federal civil immigration violations.
