#### **BILL SUMMARY**

## **Synopsis:**

SB 152 provides technical fixes made necessary by the split of CYFD and ECECD. This language is required by the Federal Bureau of Investigations so that CYFD and ECECD can continue to receive criminal history information to conduct background checks on those individuals who provide care to New Mexico's most vulnerable children.

Specifically, SB 152 provides definitions for CYFD to conduct background clearances on:

- Foster or adoptive parents
- Adults residing in foster or adoptive parent's households
- Operators, employees, student interns and volunteers of:
  - every facility or program that has primary custody of children for 20 hours or more per week
    - behavior management skills development
    - case management
    - child placement agencies
    - comprehensive community support services
    - shelter care
  - o Juvenile detention or correction facilities
  - Treatment facilities
    - Day treatment
    - Group homes
    - Intensive outpatient programming
    - Treatment foster care
    - Residential treatment facilities

In addition, SB 152 places the term "department employees" in the section requested by the FBI allowing ECECD to perform background clearances for ECECD employees.

As noted above, without this crucial legislation, CYFD will be unable to conduct background checks on those individuals who provide care to New Mexico's most vulnerable children. This legislation is necessary to ensure that CYFD is equipped with a vital tool to ensure the safety of children in state custody.
