**BILL SUMMARY**

Amends the Liquor Control Act to broaden the authority for issuance of direct shipment permits (to NM residents aged 21 or over) to include the shipment of beer and spirituous liquors (under existing law only winegrowers are able to obtain such a permit). Restricts small brewers to two 12-quart cases of beer monthly to the resident and craft distillers to 10.5 liters of spirituous liquor per month. Effective July 1, 2024.
