BILL SUMMARY

<u>Synopsis:</u>

House Bill 252 (HB 252) is amending the Aging and Long-Term Services Department Act to create a Kinship Caregiver Support Pilot Program. HB 252 outlines the purpose of the pilot as well as the areas within the state to develop and implement the program.

House Bill 252 amendment (HB 252a) is removing the appropriation.

FISCAL IMPLICATIONS

HB 252 introduces a pilot program to support grandparents and other kin who take care of children, which would then be assessed for fiscal impact for program partners such as HCA. Without specific details about the nature of the pilot, we are unable to determine how it will affect our operations or resources at this time. HB 252 does not identify the program partners or the expectations of the program partners. If HCA is determined to be identified as a program partner, there could be a fiscal implication. This could require additional staff positions.

Clause C. (6)(b) offers legal assistance. Such assistance would require a significant allocation of any appropriation, while also presenting a situation rife with ethical complications.

SIGNIFICANT ISSUES

HB 252, as currently written ISD is unable to identify or assess significant issues at this time due to the general nature of the bill. The lack of specific details does not allow the agency to evaluate its potential impact or to address any potential challenges . HB 252 does not outline which program partners will be collaborating with the Aging and Long Term Services Department to establish the pilot.
