

1 AN ACT
2 RELATING TO PUBLIC EDUCATION; REQUIRING THAT EACH SCHOOL
3 DISTRICT AND CHARTER SCHOOL ADOPT AND IMPLEMENT A POLICY FOR
4 THE USE OF WIRELESS COMMUNICATION DEVICES BY STUDENTS IN
5 PUBLIC SCHOOLS; REQUIRING THE PUBLIC EDUCATION DEPARTMENT TO
6 PROVIDE POLICY GUIDELINES.

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

9 SECTION 1. A new section of the Public School Code is
10 enacted to read:

11 "WIRELESS COMMUNICATION DEVICE--DEFINITION--POLICY--USE
12 OF DEVICE BY STUDENTS.--

13 A. As used in this section, "wireless
14 communication device" means a portable electronic device
15 capable of transmitting voice, text or data, including a:

- 16 (1) cellular phone, smartphone or
17 smartwatch;
18 (2) tablet computer;
19 (3) laptop computer; or
20 (4) gaming device.

21 B. No later than August 1, 2025, each school
22 district and charter school shall adopt and implement a
23 wireless communication device policy. The department shall
24 issue guidelines outlining the minimum requirements for a
25 wireless communication device policy, including that a policy

1 may:

2 (1) prohibit a student from using a wireless
3 communication device during instructional hours;

4 (2) authorize a teacher to permit a student
5 to use a wireless communication device for educational
6 purposes during instructional hours;

7 (3) permit a student to use a wireless
8 communication device in the event of an emergency or to
9 manage the student's health care;

10 (4) permit a student to use a wireless
11 communication device for accessibility purposes, including
12 text-to-speech, speech-to-text or other assistive
13 technologies that aid in communication, navigation or
14 learning;

15 (5) provide protections for student privacy
16 and confidentiality related to the permissible use of a
17 wireless communication device at school;

18 (6) provide for the permissible use of a
19 wireless communication device during non-instructional hours;
20 and

21 (7) provide for consequences for violation
22 of the wireless communication device policy.

23 C. A wireless communication device policy adopted
24 and implemented pursuant to this section shall not prohibit a
25 student from using during instructional hours:

1 (1) text-to-speech, speech-to-text or other
2 assistive technologies that aid in communication, navigation
3 or learning; or

4 (2) a wireless communication device if the
5 use of the device is a medical necessity, an accommodation
6 for a student with a disability or included in a student's
7 individualized education program.

8 D. Upon adoption of a wireless communication
9 device policy, each school district or charter school shall
10 publish the policy on the school district's or charter
11 school's website."
