BILL SUMMARY

Under current law, in a criminal case when the issue of a defendant's competency to stand trial is raised in Metropolitan Court, the case must be transferred to District Court. This bill provides instead that Metro Court retain jurisdiction unless a determination is made that the defendant is not competent, in which event the case must then be transferred to District Court.

PERFORMANCE IMPLICATIONS

The NMDPS supports this legislation. The legislation will significantly improve the efficiency of processing criminal cases by providing a timelier resolution following the arrest and filing of criminal charges. By providing the metro court with this ability it will enable them to quickly evaluate and resolve competency issues when the defendant is deemed competent, in essence providing for faster adjudication, quicker closure for victims, and more efficient and effective use of law enforcement resources.

In addition, the legislation will ensure needed judicial oversight when defendants are truly incompetent, but also eliminates burdensome judicial transfers, making our court system more functional.

This legislation is a practical, common-sense improvement that will help law enforcement in the metro area fulfill their mission more effectively. By reducing needless judicial transfers, when competency is not an actual issue, it will enable more resources to focus on active investigations and community needs rather than repeated court hearings.
