AN ACT

RELATING TO UTILITIES; ENACTING THE MICROGRID OVERSIGHT ACT;
PROVIDING AUTHORITY FOR THE PUBLIC REGULATION COMMISSION TO
REGULATE MICROGRIDS; CREATING A MICROGRID RENEWABLE PORTFOLIO
STANDARD; PROHIBITING RATE INCREASES DUE TO PUBLIC UTILITIES
PURCHASING POWER FROM MICROGRIDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. [NEW MATERIAL] SHORT TITLE.--This act may be
cited as the "Microgrid Oversight Act".

SECTION 2. [NEW MATERIAL] DEFINITIONS.--As used in the
Microgrid Oversight Act:

A. "commission" means the public regulation
commission;

B. "electric public utility" means an electric
public utility certified by the commission to provide retail

1 electric service in New Mexico, pursuant to the Public Utility
2 Act, that is not also a distribution cooperative utility;

3 C. "microgrid" means a permanent or temporary
4 electric system that:

5 (1) includes a self-source generation resource
6 that is capable of generating not less than twenty megawatts;
7 and

8 (2) is capable of operating independently or
9 connected to the grid;

10 D. "renewable energy" means electric energy
11 produced by use of a renewable energy resource;

12 E. "renewable energy resource" means the following
13 energy resources, with or without energy storage:

14 (1) solar, wind and geothermal;

15 (2) hydropower facilities;

16 (3) biomass resources, limited to agriculture
17 or animal waste, small-diameter timber not to exceed eight
18 inches, salt cedar and other phreatophyte or woody vegetation
19 removed from river basins or watersheds in New Mexico; provided
20 that these resources are from facilities certified by the
21 energy, minerals and natural resources department to:

22 (a) be of appropriate scale to have
23 sustainable feedstock in the near vicinity;

24 (b) have zero life cycle carbon
25 emissions; and

1 (c) meet scientifically determined
2 restoration, sustainability and soil nutrient principles;

3 (4) fuel cells that do not use fossil fuels to
4 create electricity; and

5 (5) landfill gas and anaerobically digested
6 waste biogas;

7 F. "self-source generation resource" means a
8 permanent or temporary electricity-generating resource that is
9 dedicated to primarily serving the persons connected either
10 directly or indirectly through business affiliates to a
11 microgrid;

12 G. "zero carbon energy" means electric energy
13 produced by use of a zero carbon resource; and

14 H. "zero carbon resource" means an electricity-
15 generating resource that emits no carbon dioxide into the
16 atmosphere.

17 SECTION 3. [NEW MATERIAL] OVERSIGHT AUTHORITY--POWERS AND
18 DUTIES OF COMMISSION.--

19 A. The commission has authority over matters
20 relating to the approval and operation of microgrids in the
21 state.

22 B. The commission may:

23 (1) require and collect fees that are used to
24 cover the cost of the commission's oversight of microgrids from
25 owners and operators of microgrids; and

1 (2) enter premises occupied by a microgrid,
2 during reasonable hours and after providing notice to the owner
3 or operator of the microgrid, to exercise powers or duties
4 pursuant to the Microgrid Oversight Act.

5 C. The commission shall:

6 (1) promulgate rules regarding the microgrid
7 renewable portfolio standard, including requirements regarding
8 compliance, accurate metering, energy auditing, recordkeeping
9 and reporting; and

10 (2) approve new microgrids only if the owner
11 or operator can provide evidence that the microgrid will be
12 compliant with current microgrid renewable portfolio standards.

13 SECTION 4. [NEW MATERIAL] MICROGRID RENEWABLE PORTFOLIO
14 STANDARD.--

15 A. A microgrid shall meet the microgrid renewable
16 portfolio standard requirements to include renewable energy in
17 its electric energy supply portfolio, as demonstrated by
18 accurate metering and energy audits.

19 B. Renewable energy shall comprise no less than
20 forty percent of a microgrid's total annual energy generation:

21 (1) for a microgrid that begins operation on
22 or after May 20, 2026; and

23 (2) no later than January 1, 2028 for a
24 microgrid in operation prior to May 20, 2026.

25 C. Renewable energy shall comprise no less than

1 fifty percent of a microgrid's total annual energy generation
2 no later than January 1, 2030.

3 D. Renewable energy shall comprise no less than
4 eighty percent of a microgrid's total annual energy generation
5 no later than January 1, 2040.

6 E. Zero carbon energy shall comprise one hundred
7 percent of a microgrid's total annual energy generation no
8 later than January 1, 2045.

9 F. An owner or operator of a microgrid shall issue
10 a report to the commission beginning July 1, 2027, and January
11 1 every year thereafter, that includes:

12 (1) total annual energy generation measured in
13 megawatt-hours;

14 (2) total annual energy generation of
15 renewable energy measured in megawatt-hours, organized by
16 technology type;

17 (3) the status of compliance with the
18 microgrid renewable portfolio standard;

19 (4) total water use, including water used for
20 power generation and cooling of facilities directly served by
21 the microgrid; and

22 (5) other information the commission may
23 require to verify compliance.

24 SECTION 5. Section 62-17-12 NMSA 1978 (being Laws 2025,
25 Chapter 93, Section 6) is recompiled in the Microgrid Oversight

2 "SELF-SOURCED POWER GENERATION.--

3 A. Persons located within the state may receive
4 electricity service using a ~~[qualified]~~ microgrid that may also
5 deliver electricity to equipment, lines and facilities operated
6 by an electric public utility; provided that the person and the
7 electric public utility enter into an electric service
8 agreement.

9 B. ~~[This section authorizes]~~ An electric public
10 utility, subject to approval by the ~~[public regulation]~~
11 commission, ~~[to]~~ may acquire self-source generation resources
12 or energy and dedicate those resources or energy to retail
13 services, wholesale services or self-generation services, or
14 any combination of those services ~~[and rates established for~~
15 ~~those services shall take into account the public interest and~~
16 ~~need, reliability and affordability]~~. The ~~[public regulation]~~
17 commission shall not approve an acquisition pursuant to this
18 section from a facility that does not qualify as a self-source
19 generation resource or if the acquisition would increase rates
20 or otherwise adversely affect ratepayers.

21 C. The owner or operator of a microgrid may
22 purchase energy from an electric public utility; provided that
23 the purchase does not increase rates for existing customers of
24 the utility or otherwise adversely impact ratepayers.
