SUMMARY

Synopsis of the Bill

House Bill 1 (HB1) appropriates \$66.6 million from the general fund and cash balances for legislative session expenses and to various legislative agencies for interim expenses, including fiscal year 2027 (FY27) operating budgets of the Legislative Council Service (LCS), Legislative Finance Committee (LFC), Legislative Education Study Committee (LESC), and House and Senate chief clerk offices. Other appropriations include presession expenses, the legislative internship program, expenses of the Senate Rules Committee, district office staff, and nonrecurring appropriations for IT-related purposes, capitol expenses, and redistricting expenses. The bill includes an emergency clause to take effect immediately on signature by the governor.

FISCAL IMPLICATIONS

House Bill 1 appropriates \$7.2 million nonrecurring general fund revenue to fund the expenses of the Second Session of the Fifty-Seventh Legislature (Section 1). House Bill 1 includes \$49

million from the general fund for recurring expenses for legislative offices, including LCS (Section 3), the Legislature (Section 4), the Legislative Finance Committee (Section 5), the Legislative Education Study Committee (Section 6), the House Chief Clerk (Section 7), and Senate Chief Clerk (Section 8) Offices. Other nonrecurring general fund expenses include legislative information systems for \$3.5 million, a capital outlay integrated data system for \$2.1 million, and an appropriation to the Legislative Finance Committee for economic analysis subscription costs and data analysis equipment for \$170 thousand. House Bill 1 also includes four nonrecurring appropriations from legislative fund balances for capitol repairs and upgrades (\$2.6 million), a legislative processing system (\$1 million), a census redistricting data program (\$500 thousand), and a database (\$400 thousand) with fund balance appropriations totaling \$4.5 million. Notably, Legislative Building Services (LBS) is funded in the General Appropriation Act and is not included in the recurring total referenced above. A complete picture of legislative appropriations including, the GAA recommendation for LBS, is included in the budget summary table that follows.
