SUMMARY

Synopsis of SHPAC Amendment to Senate Bill 4

The SHPAC amendment to Senate Bill 4 strikes reference to the Health Sciences Center and instead directs the appropriation to the “board of regents of” the University of New Mexico.

Synopsis of Original Bill

Senate Bill 4 appropriates \$2 million from the general fund to the Health Care Authority for the purpose of providing additional funding for Medicaid-directed payments to the University of New Mexico Health Sciences Center (UNM-HSC) to increase salaries for medical residents and fellows.

This bill does not contain an effective date and, as a result, would go into effect 90 days after the Legislature adjourns, which is May 20, 2026.

FISCAL IMPLICATIONS

The appropriation of \$2 million contained in this bill is a recurring expense to the general fund. Any unexpended or unencumbered balance remaining at the end of FY27 shall revert to the general fund.

SIGNIFICANT ISSUES

UNM-HSC has 761 medical residents and fellows with an annual payroll of \$62.5 million. The additional \$2 million appropriated in this bill would provide funding for an average increase of 3.2 percent and would be sufficient to bring the average resident and fellow pay to the 55th percentile nationally.

UNM salaries are 2.2 percent to nearly 7 percent behind the national average for medical schools and 10 percent to 24 percent behind the western regional average. However, relatively high salaries and a large number of medical residents in California drive up the average salary for the western region.

OTHER SUBSTANTIVE ISSUES

In 2024, the Legislature designated \$3.4 million in Medicaid-directed payments to provide salary increases to residents and fellows. This bill would bring the total Medicaid-directed payment revenue dedicated to resident salaries to over \$5 million.
