BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred thirty-nine
thousand eight hundred eighteen dollars (\$139,818) is
appropriated from the general fund to the board of regents of
New Mexico state university for expenditure in fiscal year 1997
for the purpose of operations of the Clayton livestock research
center. Any unexpended or unencumbered balance remaining at the
end of fiscal year 1997 shall revert to the general fund.
