BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Seventy-five thousand dollars (\$75,000) is appropriated from the general fund to the board of regents of New Mexico state university for expenditure in fiscal year 1997 by the cooperative extension service for the purpose of hiring additional staff and meeting additional operating expenses to conduct research and obtain scientific information for range improvement task force programs. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.
