AN ACT

MAKING AN APPROPRIATION TO CONTRACT WITH A NONPROFIT ORGANIZATION TO OFFER SERVICES TO PREVENT JUVENILE CRIME, DRUG ABUSE AND GANG ACTIVITY IN ALBUQUERQUE LOCATED IN BERNALILLO COUNTY; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION.--Three hundred thousand dollars (\$300,000) is appropriated from the general fund to the local government division of the department of finance and administration for expenditure in fiscal years 1996 and 1997 for the purpose of contracting with a nonprofit organization to offer services to prevent juvenile crime, drug abuse and gang activity, with staffing by off-duty and retired law enforcement personnel in Albuquerque located in Bernalillo county. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.

Section 2. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately.
