AN ACT

MAKING APPROPRIATIONS TO THE DEPARTMENT OF HEALTH TO PROVIDE OR
CONTRACT FOR DEVELOPMENTAL DISABILITIES SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATIONS. --

A. Five million one hundred ten thousand dollars
(\$5,110,000) is appropriated from the general fund to the
department of health for expenditure in fiscal year 1997 to
provide or contract for developmental disabilities programs and
services as follows:

(1) four million one hundred thousand dollars
(\$4,100,000) for increased reimbursement rates for community
services providers, as required by Section 28-16A-16 NMSA 1978;

(2) five hundred thousand dollars (\$500,000) to
provide staff development for community service provider program

2 (3) two hundred thousand dollars (\$200,000) to
3 provide comprehensive support for families of individuals with
4 multiply diagnosed conditions; and

5 (4) three hundred ten thousand dollars
6 (\$310,000) to provide civil rights liability insurance coverage
7 for nonprofit service providers for the developmentally disabled
8 and for nonprofit intermediate care facilities for the mentally
9 retarded.

10 B. Any unexpended or unencumbered balance remaining
11 at the end of fiscal year 1997 shall revert to the general fund.
