AN ACT

MAKING AN APPROPRIATION FOR HAWTHORNE ELEMENTARY SCHOOL IN THE CITY OF ALBUQUERQUE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION.--Thirty-two thousand five hundred sixty-four dollars (\$32,564) is appropriated from the general fund to the local government division of the department of finance and administration for expenditure in fiscal year 1997 for the purpose of implementing a gang and drug intervention pilot program for high-risk students at Hawthorne elementary school in the city of Albuquerque that will foster achievement, motivation and educational aspiration. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.
