AN ACT

RELATING TO HEALTH CARE; ENACTING A SECTION OF THE PUBLIC
ASSISTANCE ACT TO REQUIRE MEDICAL ASSISTANCE TO CHILDREN IN
FAMILIES AT OR BELOW ONE HUNDRED EIGHTY-FIVE PERCENT OF THE
FEDERAL POVERTY LEVEL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. A new section of the Public Assistance Act is
enacted to read:

"~~[NEW MATERIAL]~~ MEDICAL ASSISTANCE REQUIRED FOR CHILDREN
IN FAMILIES AT OR BELOW ONE HUNDRED EIGHTY-FIVE PERCENT OF THE
FEDERAL POVERTY LEVEL. --Consistent with the eligibility criteria
under the federal act, and subject to available appropriations,
the human services department shall provide medical assistance
through the medicaid program to children in families at or below
one hundred eighty-five percent of the federal poverty level."
