AN ACT

MAKING AN APPROPRIATION TO THE BOARD OF REGENTS OF EASTERN NEW MEXICO UNIVERSITY TO STAFF THE EXHIBIT BUILDING AT BLACKWATER DRAW, A NATIONAL HISTORICAL SITE NEAR PORTALES IN ROOSEVELT COUNTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Twenty thousand two hundred dollars (\$20,200) is appropriated from the general fund to the board of regents of eastern New Mexico university for expenditure in fiscal year 1997 for the purpose of providing staff to maintain the exhibit building at Blackwater Draw, a national historical site near Portales in Roosevelt county. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.
