Section 1. APPROPRIATION.--One hundred fifty thousand dollars (\$150,000) is appropriated from the general fund to the mental health division of the department of health for expenditure in fiscal year 1997 for the purpose of contracting for wilderness-based community leadership programs, for youth who fall along a continuum of risk, that use wilderness activities and challenges with principles of experiential education to build self-esteem and a positive youth culture. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.
