AN ACT

RELATING TO CAPITAL EXPENDITURES; MAKING AN APPROPRIATION TO PLAN
AND DESIGN A PUBLIC TRANSPORTATION SYSTEM IN THE SOUTH VALLEY OF
BERNALILLO COUNTY; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION.--Seventy-five thousand dollars (\$75,000) is
appropriated from the general fund to the state highway and transportation department for
expenditure in fiscal years 1996 and 1997 for the purpose of contracting for planning and
designing of transportation systems that will serve the community residents of the south valley,
including the elderly and disabled, located in Bernalillo county. Any unexpended or
unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.

Section 2. EMERGENCY.--It is necessary for the public
peace, health and safety that this act take effect immediately.
