AN ACT

RELATING TO PUBLIC RETIREMENT; AMENDING A SECTION OF THE  
VOLUNTEER FIREFIGHTERS RETIREMENT ACT RELATED TO THE AMOUNT OF  
FUNDS TRANSFERRED TO THE VOLUNTEER FIREFIGHTERS RETIREMENT FUND;  
MAKING AN APPROPRIATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 10-11A-3 NMSA 1978 (being Laws 1983,  
Chapter 263, Section 3) is amended to read:

"10-11A-3. VOLUNTEER FIREFIGHTERS RETIREMENT FUND--  
CREATION--TRANSFER OF FUNDS FROM THE FIRE PROTECTION FUND.--

A. There is created the "volunteer firefighters  
retirement fund" in the state treasury. All annuities and  
benefits in lieu of annuities shall be paid from the fund as  
provided in the Volunteer Firefighters Retirement Act.

B. Beginning in [~~the seventy-third~~] fiscal year

1 1997, the state treasurer shall transfer annually on or before
