AN ACT

MAKING AN APPROPRIATION TO THE UNIVERSITY OF NEW MEXICO FOR
HEALTH SCIENCES PROGRAMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --

A. One million one hundred ninety-nine thousand five hundred dollars (\$1,199,500) is appropriated from the general fund to the board of regents of the university of New Mexico for expenditure in fiscal year 1997 in the following amounts for the following purposes:

(1) five hundred forty thousand dollars (\$540,000) to continue the problem-based medical education curriculum at the school of medicine;

(2) three hundred eighteen thousand dollars (\$318,000) to continue the area health education center program
