16	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
17	Section 1. SEVERANCE TAX BONDSPURPOSE FOR WHICH ISSUED
18	APPROPRIATION OF PROCEEDSThe state board of finance may issue
19	and sell severance tax bonds in compliance with the Severance
20	Tax Bonding Act in an amount not exceeding three million dollars
21	(\$3,000,000) when the state highway and transportation
22	department certifies the need for the issuance of the bonds.
23	The state board of finance shall schedule the issuance and sale
24	of the bonds in the most expeditious and economical manner
25	possible upon a finding by the board that the project has been

1 developed sufficiently to justify the issuance and that the project can proceed to contract within a reasonable time. 2 The state board of finance shall further take the appropriate steps 3 necessary to comply with the Internal Revenue Code of 1986, as 4 5 The proceeds from the sale of the bonds are amended. 6 appropriated to the state highway and transportation department for the purpose of continuing construction of a bypass arterial 7 route around the northwest side of Santa Fe located in Santa Fe 8 9 county. Any unexpended or unencumbered balance remaining at the 10 end of fiscal year 1999 shall revert to the severance tax 11 bonding fund. If the state highway and transportation 12 department has not certified the need for the issuance of the 13 bonds by the end of fiscal year 1998, the authorization provided 14 in this section shall be void.

Section 2. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately.
