AN ACT

RELATING TO COOPERATIVE MARKETING ASSOCIATIONS; REMOVING THE FEE REQUIREMENT FOR COOPERATIVE MARKETING ASSOCIATIONS FILING ARTICLES OF INCORPORATION WITH THE COUNTY CLERK; AMENDING THE COOPERATIVE MARKETING ASSOCIATION ACT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 76-12-8 NMSA 1978 (being Laws 1937, Chapter 152, Section 8, as amended) is amended to read:

"76-12-8. FILING AND RECORDING ARTICLES OF
INCORPORATION.--The articles of incorporation shall be filed
with the state corporation commission, and a copy thereof, duly
certified by the commission shall be recorded in the office of
the county clerk of the county where the principal office of the
association is to be located in this state. For filing the
articles of incorporation, an association shall pay to the state

corporation commission fifty dollars (\$50.00) together with the proportionate part of the annual license fee [which] that may be due for the succeeding fraction of the fiscal year and for filing an amendment to the articles, twenty-five dollars (\$25.00). [For filing the certified copy of the articles of association with the county clerk, the association shall pay a fee of one dollar (\$1.00)]"
