AN ACT

MAKING AN APPROPRIATION FOR A MULTIPURPOSE CENTER AT JEMEZ
PUEBLO IN SANDOVAL COUNTY; DECLARING AN EMERGENCY

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --One hundred thousand dollars (\$100,000) is appropriated from the state board of finance emergency fund to the New Mexico office of Indian affairs for expenditure in fiscal years 1996 and 1997 for construction of a multipurpose facility at Jemez pueblo in Sandoval county. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.

Section 2. EMERGENCY. --It is necessary for the public peace, health and safety that this act take effect immediately.
