MAKING AN APPROPRIATION TO CONTRACT FOR SERVICES TO PROVIDE
TRANSITIONAL HOUSING AND EDUCATION FOR PAROLEES IN BERNALILLO
COUNTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Forty-five thousand dollars
(\$45,000) is appropriated from the general fund to the
corrections department for expenditure in fiscal year 1997 for
the purpose of contracting for services to provide transitional
housing and education in Bernalillo county for parolees from
throughout the state. Any unexpended or unencumbered balance
remaining at the end of fiscal year 1997 shall revert to the
general fund.
