20	judge of division one shall reside and maintain his principal
21	office in Colfax county or Union county, and the judge of
22	division two shall reside and maintain his principal office in
23	Taos County. [ <del>The presiding judge of the district shall be the</del>
24	judge holding the longest term of office.] The chief judge of
25	the eighth judicial shall be selected by a majority of the
